

**IKGA KikoFest 2020 AUCTION RULES**  
**September 26, 2020**

**GENERAL INFORMATION**

The IKGA Auction will be held on Saturday, September 26, 2020 at 12:00 Noon at the Cumberland County Community Complex, 1398 Livingston Rd. Crossville, Tennessee 38555.

High quality IKGA registered Kiko breeding stock goats will be up for auction as well as select Kiko Crossbred does. Goats will be on site for preview Friday and Saturday.

No alcoholic beverages or individuals drinking alcoholic beverages will be allowed in the Cumberland County Community Complex.

No dogs will be allowed in the area where goats are sheltered.

**CONSIGNMENT PROCESS:**

Consignment rules & forms are posted on the IKGA website [www.theikga.org](http://www.theikga.org) under Kikofest 2020. A Consignment Form indicating the number of goats you plan to consign will be accepted with a postmark on or before July 1, 2020. A non-refundable consignment fee of \$40.00 per goat is to be submitted with your consignment form. Only IKGA registered goats will be consigned with the exception of One Kiko crossbred doe for Five Registered Kiko does consigned. Goats donated to the IKGA Scholarship fund will not have a pen fee.

By July 1, 2020, each goat to be consigned will need to have submitted to the IKGA Registrar:

- a copy of the specific goat's registration papers
- any notes that you want listed in the catalog
- a reserve price on the goat, if any
- mail or email pictures to the IKGA Registrar which will need to be labeled with goat's Herd Prefix and name of animal
- Completed KikoFest 2020 Consignment Form
- Check for pen fee and IKGA membership ( if needed) made out to IKGA

The KikoFest 2020 Auction will have a limit of 75 goats including a limit of 5 bucks, which includes goats donated to the IKGA Scholarship fund.

**There must be five registered Kiko does consigned in order to consign a buck.**

**There must be five registered Kiko does consigned in order to consign a crossbred doe. Crossbred does from this sale WILL NOT BE REGISTERABLE with the IKGA.**

If you want to donate a buck to the IKGA Scholarship fund, contact IKGA Registrar, Jessica Bordewyk.

No commercial percentage bucks are allowed in the sale.

Only goats that have a READABLE tattoo or microchip that matches their registration papers will be allowed in the sale. No microchipping allowed at sale. So prior to submission of consignment papers make sure all the consigned goats have a readable microchip or tattoo.

All goats must also have a Scrapie Tag, in order to comply with USDA and Tennessee State guidelines.

All goats must have a Health Certificate from a veterinarian and **a copy of the certificate for each goat** brought to the sale.

Once all consignment information is received, there will be a drawing of consigned goats to determine sale order/ lot number in the sale catalog.

To preview goats for sale go to the IKGA website at [www.theikga.org](http://www.theikga.org) and click on Kikofest 2020. Then click on the Stock Preview button. Stock to be sold at the sale will be listed on the web site by 8/1/2020. Deadline extensions may only be granted by the registrar or the sale catalog coordinator. Deadline extensions will be determined by their workload and deadlines that have been placed upon them to meet KikoFest schedules.

**Preview online catalog after 8/1/20 to check for errors.  
Contact the IKGA Registrar to make corrections.**

When checking in goats for the sale, each goat should have:

- two copies and the original of their IKGA Registration Certificate
- a copy of their Health Certificate
